3. Content of minor

Fontys University of Applied Science, school of HRM and Psychology has developed the minor Your Future Work to educate students with a curious attitude towards human sciences. Creativity, personal leadership and entrepreneurship will be challenged and strengthened during this program.

We challenge students to craft their own future of work. From this starting point, students will develop an understanding of personal options and choices. This will enable them to create opportunities, for personal and professional use. We offer students the opportunity to combine the knowledge from their own major with a better understanding of their ambitions and expectations of the future of work.

During this Minor, the student will work on developing seven learning outcomes, as follows:

Opportunity awareness (What's out there?)	<ul style="list-style-type: none">You are able to notice your context, overcome obstacles and take the chance to gain advantage from opportunities - e.g. confidence, flexibility, resilience, openness to change - crucial to the achievement of personal and professional goals.You show the ability to learn in action: explore and enlarge your talents in a variety of (future) opportunities and environments and dare to experience and to challenge the status quo.
Decision making (What will I do?)	<ul style="list-style-type: none">You formulate a powerful vision on a futuristic (working) environment, based on a profound analysis of your self-awareness, opportunity awareness and trends in society.You can create realistic personal and professional development plans to achieve identified goals and you relate actively to your emerging future.
Contribution to society (What's my added value?)	<ul style="list-style-type: none">You can use your skills in a variety of contexts and you show how you are of added value to society. You can stimulate the development of others and improve the quality of relationships on a private and professional level.

The Minor Your Future Work (30 EC's) is concluded in a semester with the following subjects: Mental health and happiness, Career design, Intercultural awareness, Human technology interaction, Bold as love en The world and you.

4. (Admission) restrictions of the minor

The maximum number of admissible students is 30. Selection is based on the order of application. If you apply after the registration deadline, a motivation letter will be requested. Deadline for registration for the fall semester 2023-2024 is May 1, 2022 and the deadline for the spring semester 2022-2023 is November 1, 2022. Students will be informed about their admission before June 15 and December 15.

If the minor is cancelled, the student will be informed before June 15 and September 15, respectively

In the case of a not completion of YFW 1 or YFW 2, and no possibility to take a re-exam because of departure, international students (no participant of Fontys University) have the opportunity to request for a certificate, based on results achieved in the minor, according to the number of sbu's.

If YFW 1 or (not and) YFW 2 is not completed after two chances per test, the student can ask the minor coordinator for a third chance to complete the minor.

8. Passing the minor

The minor Your Future Work is completed successfully when the student takes part in Your Future Work 1 and Your Future Work 2. The student will receive **30** credits and a minor certificate when the two assessments have been graded with a Complied.

9. Examination Board (see article 38 general section of the TER)

The examination Board of Fontys University of Applied Science, School of HRM and Psychology is authorized to give an opinion on individual requests from students regarding the start and modification of a minor. The examination board is accessible via email address: examcommissiehrmenp@fontys.nl

11. Entry requirements minor

Before you can start this minor you must have passed your foundation degree (propedeutic) or have permission from your Examination Board of your institute to join this minor.

This program is available to international students and professionals, as well as to Dutch students, who may find it interesting to study in an international environment. Each potential participant for this advanced level program must meet the following requirements:

- Must have a good command of the English language (which should be further improved during the Minor)
- Must be eager to acquire new skills.
