# These rules apply to the 2020-2021 academic year

were adopted by the Executive Board on 1 September 2020 and can be found on the website of Fontys University of Applied Sciences under the heading Conditions, articles and regulations.

Please take note that you cannot derive any rights from this English version of these Enrolment conditions. In case of doubt, consult the original Dutch version.

#### 1. Introduction

Due to the COVID-19 pandemic, Dutch law has been changed for academic year 2020-2021 to allow conditional enrolment for those prospective students who were unable to meet all of the requirements regarding prior education in time, in order to be allowed to enrol in an Associate Degree programme, Bachelor's programme, postgraduate teacher training course or Master's programme. This legislative amendment has led to this supplement to the Fontys Enrolment Conditions.

#### 2. Conditional enrolment

Pursuant to Section 7.37c of the Dutch Higher Education and Research Act (WHW), in academic year 2020-2021, students may be enrolled who were unable to meet the admission requirements for a Master's programme due to the COVID-19 pandemic, which caused teaching activities to be cancelled, made work placements impossible, or meant one or more tests, exams, examinations or interim examinations could not be taken, due to government measures related to COVID-19.

## 2.3 Master's programme enrolment

Enrolment in a Master's programme is permitted without a Bachelor's degree, based on a completion advice (*afrondingsadvies*) issued by the Bachelor's programme department in question. Evidence that the Bachelor's programme has been completed must be submitted prior to 1 January 2021, unless the completion advice stated a later date (no later than 31 August 2021). In that case the evidence must be submitted no later than the date in question.

## 2.4 Terminating conditional enrolment

Students who have been conditionally enrolled in a Master's programme must submit evidence that they have obtained their Bachelor's degree no later than 1 January 2021. If a later date than 1 January 2021 has been agreed, they must submit evidence *prior* to this date (see 2.3). Any students who do not submit this evidence will have their enrolment terminated as of either 1 January 2021 or the date agreed with them.

The director may decide not to terminate the enrolment if this would result in extreme unfairness, due to force majeure causing the student to be unable to obtain their degree in time. In that case, the conditional enrolment will be terminated if the requirements in question set out in the first sentence are not met *prior* to 1 September 2021.

Once the enrolment has been terminated, the student will receive a statement listing the results obtained during the conditional enrolment period.

### 3. Financial affairs

Students who have paid the institution tuition fee based on their non-EEA nationality and who were conditionally enrolled in a Master's programme will only have to pay the institution tuition fee once during the conditional enrolment period.
